12 Brief Description of Assignment:

The assignment is to "Conduct a Rapid Study on Tourist Carrying Capacity including hotel, motel, guest-house, etc of Inani area in Cox's Bazar-Teknaf Peninsula ECA"

This assignment is targeted for Inani area to conduct a rapid survey on Tourist Carrying Capacity including hotel, motel, guest-house, and other commercial activities, etc to gain an understanding on the allowable maximum number of tourists and number of hotel, motel, guest-house, other infrastructure etc.

The major activities identified are:

- Determine Tourist Carrying Capacity including hotel, motel, guest-House, etc of Inani area in Cox's Bazar-Teknaf Peninsula ECA considering environment, ecosystem, biodiversity etc conservation and protection;
- ii. Based on the landscape planning, recent trend of tourists' influx and maximizing the ecosystem services, identify carrying capacity of the area, recommend for way forward and possible areas for developing new infrastructures (hotel, motel, etc, offices, roads, utilities, etc), possible actions for protecting ecosystem and conserving biodiversity.
- ii. Conduct mouza and parcel-based survey, identify the features, overlay with images, digitize the features and prepare GIS maps;
- iv. Develop fact sheets: detailed information about each of the features mentioned above including area, number and seasonal variation, trend and pattern (based on the available information and communities perception), Category (green, orange, red) of the establishments according to Environmental Conservation Rules 1997, human interactions and purposes;
- v. Landscape plan showing conservation area, forests, sea-beach, recommended tourists places and infrastructure development areas, and zoning;
- List of hotel, motel, guest house, restaurant, other infrastructure in Inani area including accommodation capacity, water use, status of waste and its management;
- vii. Present status of light pollution (artificial lighting at night which deters nesting of sea-turtle) and noise pollution and its impact on biodiversity and recommendation for possible control;
- viii. Status of use of plastic and other non-degradable materials (bottle, shopping bag, etc), status of solid waste and its management system.

 - (a) Proven experience in conducting at least 3 nos. of participatory land use survey, image analysis, preparing fact sheets, administering mixed method survey;
