The *Government of the People's Republic of Bangladesh* has received financing from the World Bank toward the cost of the Clean Air and Sustainable Environment (CASE) Project, and intends to apply part of the proceeds toward payments under the contract for *Supply of Manpower on Outsourcing Basis*.
2. The *Department of Environment* now invites sealed Bids from eligible Bidders for supply of 3 Computer Operators, 1 Data Entry Operator, 11 Drivers, 9 MLSS's, 12 Security Guards and 2 Cleaners for the period of 01.12.2017 to 15.12.2018.
3. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers –July 2016" ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from *the Office of the Project Director, CASE project – DoE Component* and inspect the bidding document during office hours (09:00 to 17:00 hours) at the address given below.
5. The bidding document in English may be purchased by interested eligible Bidders upon the submission of a *written* application to the address below and upon payment of a nonrefundable fee of BDT 1000.00 (BDT One thousand only). The method of payment will be Pay Order / Bank Draft in favor of "*Project Director, Clean Air & Sustainable Environment (CASE) Project*" from any scheduled bank of Bangladesh.
6. Bids must be delivered to the address below on or before *15.10.2017 14:30 hours*. Electronic Bidding *will not* be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on *15.10.2017 at 15:00 hours*.
7. All Bids must be accompanied by a *Bid Security* of *BDT 1.50 lac (BDT one lac fifty thousand only)* in the form of Pay Order / Bank Draft / Bank Guarantee in favor of "*Project Director, Clean Air & Sustainable Environment (CASE) Project*" from any scheduled bank of Bangladesh.
